Phantom Flyers R/C Club Meeting Minutes – 15, April 2024

Attendees: 11 club members were in attendance, Meeting called to order at 6:30pm. Members were, Ed White, Jose Espinosa, Harold Weaver, Don Grzina, Bill Reape, Kevin Cox, Mitch Galatioto, Jack Buydos, Jim West, Larry Anderson, Mike Wallis.

New Members: None

Technical Session: Kevin talked about his scratch build jet. It has a 3D printed fan and is made from Depron Foam. At 9 oz it is less than the 250-gram module requirement,

Secretary's Report: The minutes were sent out for the March meeting.

There is a correction needed for the February minutes. The FAA started required compliance with Remote ID on March 16, 2024. There are several ways to comply with the Remote ID requirement. 1) Easiest is to fly at a AMA flying field that has a FRIA designation. Our field and many of the other clubs int the area has FRIA designation. At a FRIA site, just go fly as you have always flown. 2) Any plane that weighs less than 0.55 lbs is exempt. 3) Fly with a Remote ID module if neither 1) nor 2) apply to you.

Unrelated to Remote ID, the altitude limits for most fliers are specified in the current FAA Authorization law passed by congress. That limit is 400 ft AGL. Unless the club has an LOA (like our club does). The current FAA Authorization law will expire soon and is in the process of being re-authorized. The new authorization law as currently going through congress will do away with the 400 ft altitude limit and replace it with a limit to fly below either 700 or 1200 ft depending on location. This does not affect our club because we have a Letter of Agreement (LOA) allowing us to fly up to 2000 feet, weather permitting.

There was a motion by Mitch G. and seconded by Don G. The minutes were approved.

Treasurer's report: There were two applications that were returned to sender in a mail carrier mix up. They have both been received and deposited.

Safety Report. No safety reports. Don Grzina reported that he was removing foam residue with acetone and it splashed in one eye. He did go and have it checked. He recommends that safety glasses should be used if you're working with solvents. Please be "Safe" as safety is each pilot's responsibility.

Field Managers report: Don reported the runway repair has started but not finished. Mowing schedule has had one revision so far. Revised mowing schedule is up on the website.

Activities Report: Jack Buydos has agreed to be the event leader for the Open House this year. 2024 Schedule has been posted. No comments or corrections have been reported. 2 Meter Glider contest will be held Sunday May 5th.

GSLMA Report: Harold reported there was no meeting in March.

Old Business: Ed White reported the FAA may be doing checks at flying fields for a correct identification and FAA number on the aircraft and if you have your Trust Card. A Trust card or a photo on your phone is acceptable. Compliance is encouraged. The letter of agreement from the airport is also on the website if you would like to download it.

New Business: 2024 budget was corrected. The insurance for the locker on the field is \$45.00 not \$35.00. Resubmit to Mark Twain Hobby Shop with an updated list of members.

Meeting adjourned at 7:00 pm.

Safety First and Always!

Recently, an acquaintance failed to pay close attention when starting his large 35% RC airplane with a 120 CC gasoline engine. The photos show the results.




He was using the proper restraint mechanism however while hand propping his engine (without gloves on) he had failed to notice that the aircraft had rolled back several inches. The restraint held the airplane from moving forward but not backward. When the engine started it lunged towards him and he quickly reached down to hit the throttle on the transmitter as it laid on the ground. He swung his hand into the spinning prop and lost some body parts. The prop was carbon and therefore much sharper than a wooden prop.

I think the safety lesson is fairly obvious. When operating our models always consider the propeller a potentially dangerous weapon.

We completed our first of the year Phantoms 2-meter glider contest. I arrived at the field around 9:00 to set up and noticed immediately how nice the field looked. The grass was freshly cut and the field was very inviting. We started our first round at 10:00.

We had 6 flyers and 3 observers/helpers. A little lighter turn out than previous contests so the contest was completed by noon.

The weather was great and around the time of the second round the thermals were popping.

We only had one very mild adverse incident and that was mine. On my first landing I flipped over and broke the servo tray loose from the fuselage so I was out of the competition.

The five remaining competitors flew 5 rounds with 6-minute goals for the first 4 rounds and unlimited time for the fifth round, as long as your total time for all 5 rounds did not exceed 35 minutes. We also got points for landing in a corral.

All contestants were flying electric gliders so we set up on the south end of the runway with our chairs on the tarmac. That arrangement showed me having an all-electric glider competition at the Phantoms field can easily be done. Plenty of room for everything.

Rich Rennecamp maddened his new replacement Radian just before we got started and got points for every one of the rounds.

Kevin had told me he would be a little late and arrived around the end of the third round. He quickly flew the first three rounds and was then in the normal rotation.
