And since then, another new member Nick Vizgird - Welcome!

Just a few notes on our operations:

The safety rules are available on the club website (phantomflyersrc.com). The safety line is the near edge of the runway and it extends to infinity in both directions, please stay on the far side of that line. The exception is we allow gliders to pretty much free range all over, except not over the pilot line, pits, pavilion or parking lot.

Our field is about 1/3 inside of the St Louis Airport controlled airspace (from ground level on up). We have a signed agreement with the FAA allowing us to fly in controlled airspace. In fact, we can fly up to as high as 2000 ft AGL (Above Ground Level). But the requirements are we must share the airspace with manned aircraft. The no ifs, ands or buts of <u>share</u> means we absolutely stay far out of their way at all times and under all circumstances. It also means we stay at least 500 ft below the lowest clouds.

We also must abide by the FAA requirements to get and have a current registration number (renewed every 3 years) and have that registration number somewhere on every airplane you fly. We also must take and pass the FAA TRUST test (a one-time thing). If you have any questions or need any help with FAA requirements, please let us know. Just by flying at our field you automatically meet the Remote ID requirements. You don't have to do anything else to comply with Remote ID.

If you have any questions about any club requirements, don't hesitate to ask.

Club meetings are the 4rd Monday of the month, usually at 7 pm. At the flying field May thru September and online via Zoom October thru April. In December we have no formal meeting and instead have a holiday dinner (black tie required, except for the President who can wear formal cargo pants).

A last note. We communicate information to the club members via an email list through groups.io You are highly encouraged to join this group and invitations were sent to all who provided emails. Please do join this group. It's free and you don't need to make up another &E2\$%!@vlux password. Anyone can send an email to the club by sending an email to <u>phantomflyersrc@groups.io</u> Anyone not in the group member will automatically get their email reviewed/approved for content. You would not believe the number of emails I see from companies in China wanting to know how many 10's of thousands of cardboard boxes Phantom Flyers RC Club needs to send out their product line.

Proposed New Safety Rule

Please read this before the September Meeting (Sep 16)

The Board of Directors of the club wants to propose a new field safety rule. The approval process for changes to the field safety rules are that changes are approved by a simple majority vote at a regular club meeting. Which means the <u>meeting attendees</u> at the meeting decide if a rule is added, deleted or modified.

This purpose of this email is to communicate the proposed new rule in advance of the September club meeting so that members can review it, think about it and decide if they want to attend the meeting to make their vote heard. If you can't make the meeting, you can still make your comments heard by contacting me or any member of the Board of Directors.

Rationale:

Most of us know that there was an incident at a local area club where a member of that club was seriously injured starting a gas engine. The incident raises a general question of who is responsible for the safe handling of an airplane? My assumption has always been that the owner of the airplane has ultimate responsibility to ensure that necessary safety equipment is available and is used properly. My belief has been it is not up to the club or the AMA to tell airplane owners what they need or how to operate their airplane. Only the owner of the airplane knows their airplane well enough to know what safety equipment is needed and how it needs to be used. I think this is a fairly common and reasonable approach to safety that is practiced widely throughout model aircraft operations.

But I had to ask myself, in more than ... well, many decades of building and flying model airplanes, has anyone ever said the words to me that I am responsible for safe operation of my airplane? The answer is no, no one ever told me that. I just came to assume that was the case. But it is not stated in our current field safety rules and, in my opinion, is far more important than many of those rules. The Board of Directors unanimously agrees it should be explicitly stated.

Proposed new safety rule:

"The pilot of an aircraft is solely responsible for obtaining suitable equipment and its effective use to safely start and maintain full control of all aircraft systems during startup, or energizing of propulsion system elements, taxi or otherwise moving the aircraft to takeoff position and through shutdown or de-energizing of propulsion systems after landing."

The wording here is not chiseled in stone, any member can suggest modifications. Although, if the modifications are beyond clarifications, we will vote on a new *proposed* change at the meeting and table the vote on actually implementing the change. I'll then send out another email with the updated proposed rule in time for people to review it and vote on it at the October or later meeting. I don't see this as time critical so I would rather everyone have an opportunity to make any comments.
